Conservation Commission Meeting Meeting Minutes March 2, 2023

Simon Brook and Jeff Zilberman were present before the commission to continue discussing the work that has been done at 24 Paul Revere Road that is not per plan. Brook addressed the commission by clarifying that they are asking for guidance as they have come to the opinion that the plan they initially submitted and that the commission approved has become impossible to bring to fruition. He asked if there was a way to resubmit a plan so the work that has been completed can remain in place.

Philibert shared photos of the site on his screen describing in detail what work was completed that was not included in the approved plans. Notably he stated that rocks were placed 20 feet beyond where they were supposed to be and the backyard was never supposed to be flat. Philibert stated the approved plans called for a six foot change in elevation.

Brook informed members the project became complicated during work on the cesspool and that is when it was decided to alter the project for a flatter backyard. Arguimbau suggested work be done to get the site into compliance with the proposed and approved plan. Brook asked for permission to include a 25 x 25 foot stone patio. Zilberman asked if it would be possible to leave the work that has been completed as is?

Arguimbau reminded Brook and Zilberman their project needed to comply with what was initially approved. She also reminded them that Brook had previously mentioned bringing back ideas for how to remedy the situation as what has been filled, and flattened was not in the approved plans.

Philibert asked if it would be possible to move boulders back to what the approved limit of work was? He explained that allowing work 20 ft further into the wetland than what was agreed upon would set a precedent.

Brook asked for the opportunity to come back to the meeting on 16th and present a new plan.

The commission and Philibert discussed sending a letter to property owners in the subdivision alerting them to a deed restriction allowing for no more than 8,000 square feet of lawn area. Cremer noted there was an additional area in the photo next to the lot at 7 Wadsworth Way that looked like it had been cleared. Philibert made a note to bring that up for discussion when the matter is taken up again when the property owner is present.

Natural Heritage confirmed the presence of an additional rare plant in the lake: resupinate bladdwart (*utricularia resupinata*). Philibert also reported to members that he was accepted into a volunteer program with the Plant Conservation Trust and NHESP to help monitor and check for rare plants in water bodies throughout New England.

Philibert has also been in touch with Peter O'Cain and Kevin Davis representing the commission in its stormwater authority capacity. There was a pipe letting out filthy water in Massapoag Brook. The DPW is investigating the cause of the situation.
