# Conservation Commission Meeting Sharon Community Center July 11, 2019 – DRAFT

Margaret Arguimbau, Chair, Keevin Geller, Jon Wasserman, Michael Donatelle and Stephen Cremer were the members present. Absent were: Meredith Avery and Alan Westman. The Conservation Administrator, Greg Meister, was present.

### 7:45 p.m. Notice of Intent

364 Mountain Street – Creation of a pasture and horse paddock located within the 100 foot buffer zone

Karen Skinner Catrone was presenting for the applicant Dhruv Grewal. She explained that Grewel owns two horses which are currently being housed in Middleborough. At this time, Grewal would like to bring them back to Sharon. Catrone showed Commissioners the property plan showing the area of the property Grewal would like to fence off for the horses. This area will be cleared of both trees and the stumps with sand being put in. Another area of the property will also be cleared of trees and stumps, but will remain in a natural state. Arguimbau asked Catrone if it would be possible to move the sand outside of the 100 foot buffer. Grewal was consulted and agreed sand could be moved out of the 100 foot buffer.

The property was flagged on 5/4/19 and 5/19/19. Catrone met on site with Meister to review the line. A few of the flags were moved to better reflect the wetland area. There will be no work on the house and the tree line will remain.

Catrone explained to the Commissioners that prior to purchasing the home, Grewal met with the Animal inspector about the possibility of housing horses. According to Grewal, the Animal inspector said that in regards to the Towns animal regulations, there was enough property to house horses. Arguimbau asked how many trees were to be removed. Meister responded that the area that was being looked at was pretty scrubby and will be clear cut. At this time however, the applicant is still waiting to hear from Natural Heritage. Removal of the trees will be outside of the 50 foot buffer.

Catrone was asked how many low areas needed to be filled and why couldn't the area be left low. Catrone explained that the applicant wished for the area to remain natural but that it also needs to be safe for the horses. They are not building a horse ring; the area is primarily for the horses to roam freely.

Grewal has contracted with a dumpster service to remove manure. The manure will be removed every six weeks.

The size of the lot is a bit over 3 acres. Approximately 3/4ths of an acre will be cleared for the horses, most of which is scrub.

Arguimbau noted that the hearing will not be closed as the DEP has yet to issue a number.

Arguimbau consulted with Meister about putting a Conservation Restriction (CR) on the back of the property. Arguimbau explained to Grewal that a CR runs with the deed of the property. The area looking to be protected is towards the back of the property where the wetlands are, and would be permanently protected and not buildable. Arguimbau asked if the back line could be straightened out (fifty foot back to the corner back of the lot). A boiler plate of a CR will be sent to Grewal where they can include what would be allowable on the land to be protected.

Reminder that a boilerplate CR should be sent to both Catrone and Grewal.
