Watsky presented on behalf of the group. Watsky drafted an attorney's affidavit stating the minor modifications on the plan, the names and dates of revisions, the OOC number and subsequent amendments as well as where it is recorded in the registry. With the Conservation Commission's approval, the affidavit can be recorded in the title so anyone searching for the property and status of the OOC would find it in the referenced plans. Of the six separate sheets submitted of the revised plan, each one will be listed by name and revision date. Plans will not be recorded, instead only referenced. There were no other comments.

8:40 PM Other Business Briggs Pond Lake Level Issue

Members of Briggs Pond Homeowners Trust addressed the commission about water levels at Briggs Pond with information regarding: water levels, management plan schedules and procedures, and historical levels. Arguimbau and Thomas went to Briggs Pond to assess water levels and impacts on water levels.

Bruce Moyer, 9 Briggs Pond Way, who has lived in Sharon for 34 years noted his physical mobility issues prevent him from enjoying the lake when water levels get too low. His concern for any management plan utizling a dam will lower water levels too much for him to enjoy the body of water.

Arguimbau explained that some peoples' properties were facing increased water levels and a require hydrologist to formally assess the cause. Leslie Koval, a trustee, reported back that the plan to install a gauge (per request from the Conservation Commission) had been a success for 2021. Naomi Weiner presented on behalf of her mother, Esther Weiner advocating for continued monitoring and management.

Barbera reported to the commission that the LMC is collaborating with the Massapoag Yacht Club, the Board of Health, the Department of Public Works, and the Sailing Club. The LMC would like to expand the charter so all groups are formally coordinated. Noah Siegel will be invited to the October 21st meeting.

9:04 PM Other Business Cranberry Bogs

Members discussed obtaining the cranberry bogs before work was finished on restoring them. On behalf of the town, Maria Del Fuente is working on a grant application for funds that would help bring the bogs back to working conditions. As the bogs also date back to the Civil War era, there may be some CPA funds available. The current owners are motivated to turn over the bogs by October 1, 2021. Geller and Westman expressed concerns with acquiring the land before the work was done. Geller suggested a bond as a potential component of the agreement until the work is completed.
