

Finance Committee Meeting

Minutes – March 30, 2015

Town Hall, Lower Level Hearing Room, 8:30 P.M.

1. Bill Brack, Chair, explained that this meeting immediately followed the Priorities Committee meeting. Voted at Priorities unanimously. There were two votes. One was to adjust the most recent spreadsheet adding \$625,000 one-time revenue to bring the tax rate to 5%. The second vote was to have allocation of the process based on budgets used in the spreadsheet. Part of our budget review.
2. The next agenda item was review of open budget issues and FY'16 budget. Two Warrant articles, Articles 4 and 5. Article 4 is Personnel. Vote on Article 5. Budget & Compensation of Elected Officials.
3. There was considerable discussion regarding the Board of Health Budget and changes in personnel and added expenses. Then discussion on Town Clerk's salary.
4. A **MOTION** was made by Chuck Goodman and **SECONDED** by Pat Achorn to raise Town Clerk's salary 3%.
5. There was some discussion on the Town Clerk's salary.
6. A **MOTION** was made by Gordon Gladstone and **SECONDED** by Ira Miller to amend Town Clerk's salary to 3.5%.
7. Motion was 3%.
8. **VOTED:** 6-2-1. For: Achorn, Brack, Gladstone, Korin, Miller, Philips. Against: Cohen, Nelson. Abstain: Goodman.
9. Amended motion was 3.5% salary increase, budget to be \$146,111 total.

11. A **MOTION** was made by Ira Miller and **SECONDED** by Ted Philips to increase the Finance Committee sector budget by \$2,702 for a total budget of \$522,518.

13. Selectmen's Department budget decreased to \$401,537. Selectmen's sector budget decreased to \$13,110,678.

73. Article 11. Stabilization Fund. \$100,000. Would not receive improved bond rating from Moody's until more reserves.

79. **VOTED:** 5-4-0. For: Achorn, Brack, Cohen, Goodman, Philips. Against: Gladstone, Korin, Miller, Nelson.
80. A **MOTION** was made by Ted Philips and **SECONDED** by Gordon Gladstone to make their recommendation at Town Meeting on Article 18. Civil Service Rescission.

81. **VOTED:** 9-0-0. For: Achorn, Brack, Cohen, Gladstone, Goodman, Korin, Miller, Nelson, Philips.
