DISCUSSIONS

Cyanobacteria

- Committee discussed purchasing new cyanobacteria tests in the early spring 2024 (they have shelf life of 9 months). The decision to close the beach or lake is the BOH's to make. When reporting a significant algal bloom to MA Dept of Public Health, there is a mandatory 2-week closure (no boating and swimming) until two tests come back negative. In addition to visual sightings, Josh and Debbie do microscopic analysis, and Debbie has been running cell count tests this summer to help inform monitoring. We also used test strips in the past to provide warnings and to inform the BOH, but they were more sensitive tests for pet and farm animal safety (as they drink the water and lick off fur). Can we get a test that tells us we should close an area of the lake for swimming? Debbie recommends a good test strip or recreational safety from Abraxis (now Gold Standard Diagnostics): https://www.goldstandarddiagnostics.us/home/products/rapid-test-kits/algal-toxins/
- The microcystin test for safe recreational use (5 kits) costs about \$200:

- In addition to LMAC purchasing next year, we should tell residents to use these tests (instead of Blue Green tests), and what to look for in regards to the results (i.e. what levels make it unsafe to swim). To purchase five tests the cost is about \$200 and 20 tests are about \$600.
- We agreed to spend up to \$200 (chair has that authority) to copy and post signs Leandra created for Memorial Beach to warn people about blooms late August through October, should visible blooms recur. Signs could be placed at Fletchers Cove, Arboro Beach, Massapoag Yacht Club, 123 Beach St, Beach Rd, etc. Recommend Recreation Department post signage at Community Center Beach.

DASH

We had 8 days of DASH in South Cove scheduled for Sept 18 but need approval from DFW/NHESP;
 botanist surveys completed and submitted on Friday. Josh to reach out. We need to perform DASH
 before Fanwort dies and releases nutrients back into the water.
