MINUTES SHARON BOARD OF SELECTMEN

December 9, 2014

The meeting of the Sharon Board of Selectmen was called to order in the Selectmen's Meeting Room at Sharon Town Hall at 6:45pm with Chairman William A. Heitin, Clerk John J. McGrath, Selectman Walter B. Roach and Town Administrator Fred Turkington.

Friends of the Sharon Council on Aging Raffle

Gordon Gladstone explained the purpose of the Friends of the Sharon Council on Aging and activities the Friends are involved with. The raffle is one of two fundraisers they hold each year.

The Board selected the twenty-four winners of the raffle. Mr. Gladstone thanked those who contributed by buying raffle tickets and providing the prizes.

Conservation Commission Update - Peg Arguimbau

Ms. Arguimbau noted that she and Keevin Gellar are both up for reappointment this year. She said that it has been a bumpy time for the past couple of year and that the issues concerning monitoring the boat launch were complex. As an update, the Town Administrator met with Ms. Arguimbau, Ms. Levasseur and Greg Meister and the hope is to have someone monitoring the boat launch around April. The introduction of the invasive species was another issue to deal with, as the drawing down of the lake level was an effect of the treating of the lake. Ms. Arguimbau discussed the issues regarding Hammershop Pond Dam and the Commission is pleased to hear that the Board intends to replace the dam. She noted that the Commission is always looking for land preservation opportunities.

In response to a question from Mr. McGrath, Ms. Arguimbau said that she has been serving since 1984 and that there has been a good amount of turnover over the years. Selectman Roach commented that it appears that they have not had a quorum but Ms. Arguimbau explained that there were several instances when they were down a member that it was difficult at times. Selectman Roach asked if the Commission voted unanimously to support the rebuilding the Hammershop Pond Dam and Ms. Arguimbau replied that in the end, it was a unanimous vote, but some members had some initial hesitation.

The Board thanked Ms. Arguimbau for her time.
