Town Hall Renovation Project

- Mr. Marks stated that he and Mr. Paton performed an additional investigation on both buildings and it was determined that not as much asbestos was found as feared therefore we can account for the \$300,000 figure for hazardous materials.
- Mr. Marks had the estimators recalculate the numbers to include updated BKA design fees, and the Verizon fiber move. The project budget is at \$13,000,000.
- Mr. Marks will investigate the potential impact to materials cost because of Hurricane Harvey.
- Chair Gladstone asked Mr. Marks to find out why Foxboro reported their New Town Hall at a cost of \$6,700,000.
- Mr. Paton provided two renderings which showed examples of what each of the two samples of planks would look like on the building. A brief discussion ensued.

- Chair Gladstone commented that \$122,000 worth of omissions was due to the architects not completely understanding the needs of the departments as pertains to IT. He wants to focus on this as it relates to the New Town Hall Building.
