SPECIAL TOWN ELECTION

January 23, 2007

Pursuant to the provisions of the Warrant of December 5, 2006, the inhabitants of the Town of Sharon qualified to vote in elections, met in the Sharon High School Gymnasium at 7:00 A.M., Tuesday, January 23, 2007. The warden for the election was Lynne M. Callanan. The wardens for Precincts 1, 2, 3, 4 and 5 were named as follows: Pat Zlotin, Barbara Testa, Marilyn Lamb, Shirley Schofield, Susan Slater. The meeting was called to order by Marlene B. Chused, Town Clerk, who read the call and return of the warrant. Clerks and workers were: Lorraine Forman, Jini Karelitz, Terri Spevock, Pat Walker, Carol Tomasello, Carol Brown, Lori Small, Bobby Hall, Dorothy Kaufman, Ruth Grandberg, Trudy Leonard, Joel Alpert, Mildred Worthley, Marcia Shapiro, Herb Pozner, Hy Lamb, Mort Kaufman, Jim Testa, Barry Zlotin, Ilan Fisher, Phill Chapman . The ballot boxes were locked and the keys delivered to Officer of the day, Michael Hocking. All election officers were sworn.

At 8:02 P.M. the polls were declared closed. Total votes were as follows: Precinct 1 - 327; Precinct 2 - 348; Precinct 3 - 486; Precinct 4 - 283; Precinct 5 - 299. Total votes cast -1,743. Absentee ballots cast - 50. The ballots were canvassed according to the law by an OPTECH III-P Eagle Ballot Tabulator. Results were transcribed on summary sheets and declaration was made by Town Clerk Marlene B. Chused at 8:08 P.M. as follows:

QUESTION NO. 1

Shall the Town of Sharon be allowed to exempt from the provisions of proposition two and one half so called the amounts required to pay for the bond issued in order to purchase in the name of the Town for general municipal purposes, conservation purposes and/or school purposes, the fee in portions of the following parcels of land:

The parcels of land in Sharon, Massachusetts, identified as (1) 161 Lakeview Street, consisting of 46.7 acres and shown as Parcel 'B' 'remaining land of Horizons for Youth' on a plan entitled 'A preliminary subdivision plan in Sharon' dated July 1, 1998 and (2) 229 Lakeview Street, consisting of 10.00 acres and shown on said plan as Parcel 'C' "Other land of Horizons for Youth." The parcels are also identified on the Town of Sharon Assessors Map as Parcels 41/34 and 41/1 respectively, or as the same may be more particularly described.

Such property is also generally shown on a GIS map on file with the Town Clerk and a copy of the above referenced plan is on file with the Town Clerk and is entitled 'Horizons for Youth, Proposed Acquisition - November 7, 2006', and consists of the land outlined in red on said plan excluding that parcel outlined and hatched in blue and identified as 'proposed recreation land' and also excludes those three parcels outlined and hatched in yellow identified as 'proposed open space.'
