1 - When the meeting is about to start, click this link: <https://zoom.us/j/6619331292> or navigate to <https://us04web.zoom.us/j/6619331292> in your web browser and **Join The Meeting** using this Meeting ID: **661 933 1292**.

The first time you use Zoom, a desktop client will be installed. Connect with computer audio to use your computer's microphone and/or speakers. You will need to wait until the Host starts the meeting. Once the meeting starts, use the control in the top right corner to choose **Speaker** or **Gallery** view. You might want to pin the host video stream instead of having the video switch between participants as they speak while in Speaker mode.

2 - If you don't have a microphone and anticipate that you may want to speak, you can dial in using any one of these phone numbers and supply the Meeting ID: **661 933 1292**.
