Email Correspondence Update

Wendy Alexis-Janvier shared the email correspondence received from May 20, 2021 through June 20, 2021.

Message on Sharon Facebook Pages

Ms. Mitlin shared the concern of a town member on the negative discourse on Sharon Facebook groups, specifically Sharon What's Up and Everything Sharon. There is a person who has been spewing hostile, disrespectful, racist, and anti-Semitic speech online. The person in questions serves on 2 town committees. The town member has contacted the Select Board, Town administrators, and Facebook group administrators. She feels that there has been no reprecaution on this matter. This is concerning to her because the person represents our town. The DEIC discussed their opinions, ideas, and experience with the social media groups. Vice Chair Ledbetter shared her negative experience with the such groups. She noted if there is someone representing our town who is engaging in negative manner, the power is in our vote. We need to elect them off. Due to free speech, there is nothing we can do to hinder the persons actions. Select Board Member Switlekowski clarified that elected, not appointed officials can be voted out. She also shared that the town is aware and Fred did address it. She has reached out to the individual. She also reiterated free speech and the social media groups are not town sanctioned Facebook groups. She suggested creating a social media policy for town officials, that we can encourage, similar to the town of Easton's policy. Ms. Mohammad shared that in addition to policy, it is important for committee members and town officials to lead by example. Ms. Mitlin asked if the DEIC can make a public statement on the matter. The resolution is that Ms. Mitlin will write a draft statement that we can vote on to decide whether we will share it on social media platforms on behalf of DEIC.

Juneteenth Celebration Discussion

Ms. Alexis-Janvier shared her thoughts on Juneteenth. There has been a tremendous increase in interests in celebrating Juneteenth. Due to timing, we cannot host an event this year, but hopefully next year the committee can take the lead for an event for the Town of Sharon. The goal is to remember that Juneteenth is not just a moment to celebrate, but an opportunity for allies to learn. Vice Chair Ledbetter shared that SREA has done activities and agrees that we should share and educate our community. Rev. Dr. Kondrath shares that he is all for learning more, however, he would like this linked to the John Lewis voting rights act. His feeling is that Congress was quick to give a holiday and not pass the voting rights act. He would like Juneteenth and the voting right linked to the July 3rd event. Chair Pierre-Louis shared that budget is also a consideration.

Discussion about DEIC future, mission, charge, and next steps -update and changes

On June 8th the Select Board voted to continue with the DEIC. The committee revisited the mission and charge updates provided by Frederic Turkington, the Town Administrator. Rev. Dr. Kondrath shared an idea of staggering the committee composition.
