- Toben Asklar agrees with supporting this event financially and with volunteers.
   They wonder if the support comes from The Town of Sharon, not just the DEIC.
- Wendy asks to take a motion, contingent on the funds, to partner with Be Inclusive and their Juneteenth event.
  - CP adds friendly amendment, initiative be contingent on funds from the Town of Sharon. Shelley and Toben accept the motion. Shelley Keimach makes motion. Toben Asklar seconds the motion.
