Ms. Alexis-Janvier read a summary of the correspondence received between January 12 – January 28, 2021. Chair Pierre-Louis shared additional details on the South West Advisory Program invite. Grant Team Update

Lt. Coffey gave a summary of the list of grants that he and Mrs. Alexis-Janvier have been able to find. Currently there aren't that many grants available for diversity training initiatives. Lt. Coffey would like to continue to do research on possible grants and then follow-up with the committee when something becomes available. Select board Chair Emily E. Smith-Lee suggested that the committee reach out to Sharon business owners for funding. Ms. Mitlin suggested looking into the anti-defamation league for funding.

Finalizing DE&I Training

Town Administrator Frederic Turkington had some clarifying questions regarding the upcoming DE&I training. The questions were in regards to the makeup of the training group, payment structure, and time table of the training program.

Indigenous People Day

Town Administrator Frederic Turkington is researching the next steps for the Select board's discussion on the change Columbus Day to Indigenous Peoples' Day. The School Committee asked that the DEIC to advise their committee on changing Columbus Day to Indigenous People's Day. Ms. Mitlin shared that she called the Metco office for information. The Metco program shared that each school district/community are making their own decisions. Ms. Zinno shared that in addition to a change, there is a need for education. Mrs. Alexis-Janvier also shared that the decision is also made at the school level as well, and typically includes education around the holiday and history. Ms. Mohammed shared her experience with the approach the Sharon school system has taken around Indigenous People Day's. Select board Chair Emily E. Smith-Lee provide some recommendation to how the DEIC should consider their approach on advising the school committee with a lens on DEIC. Chair Pierre-Louis provide a summary of the history of Columbus in the Caribbean and America's and the impact on Indigenous people.
