### **Meeting Initiation**

Chair McLaughlin called the meeting to order (via ZOOM) at 7:11 PM.

#### **Meeting Minutes**

Mr. Blaszkowsky moved to approve the minutes of 1/11/24 and Mr. Maidman seconded the motion. The Board voted 5-0-0 in favor of approval.

#### **MBTA Zoning Community Engagement**

The Board reviewed the public outreach presentation prepared by JM Goldson and gave their thoughts and suggestions for changes for the meeting on February 13<sup>th</sup>, 2024. ### **ANR 429 E Foxboro Street**

# **ANR Costco Sharon Gallery**

Matt Smith Engineer for Norwood Engineering and Bob Shelmerdine Attorney for the applicant came before the Board asking for an ANR to create 3 lots at the Costco designated property.

The revision date of the plan is 2/7/24. The plan as per Mr. O'Cain has the required content. The lots are for Sharon Gallery, 144 Old Post Road, Sharon, MA.

Mr. Pannone asked Mr. O'Cain if he has any concerns regarding the exit and entrance to the property.

Mr. O'Cain said no. We are providing an easement to the Gallery. Costco is an anchor store at the Gallery.

Mr. Blaszkowsky moved to adopt the ANR for Costco property and to appoint Peter O'Cain as Agent for the Board to answer any additional issues. Mr. Maidman seconded the motion. The Board voted 5-0-0 in favor of approval.
