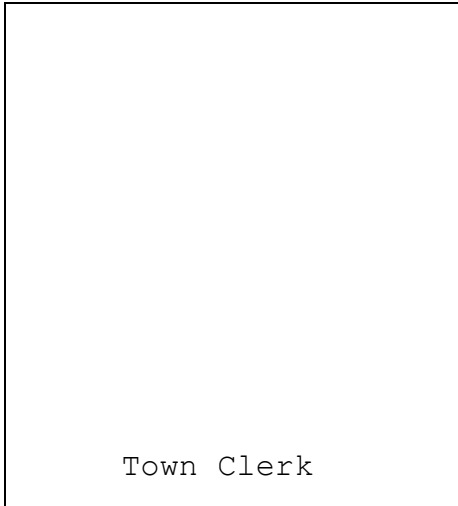

You might want to pin the host video stream instead of having the video switch between participants as they speak while in Speaker mode.
