

Conservation Commission Meeting

Peg Arguimbau, Chairperson, Stephen Cremer, Alan Westman, Betsy McGrath, Keevin Geller were the members present. Meredith Avery and Linda Orel were not present. The Conservation Administrator, Greg Meister, was not present.

Meeting started at 7:45pm

7:45 PM – Notice of Intent, 56 Highland Ave., Saphire Manor

Raze and reconstruction of building. David Oberlander, representing the applicant. Saphire Manor is located off of Massapoag Ave and Decatur. The lot consists of two buildings. Saphire Manor (for functions) and Saphire Inn (lodging house). The lodging house is not in good shape and the plan is to tear it down and build at that location, using the existing buildings footprint. Most of the lot is surrounded by wetlands.

The new building will consist of offices, a prep kitchen and a reception area which will connect to Saphire Manor.

Drainage at the site will be improved. A rain garden is being proposed between the new building and Saphire Manor. Drainage from the roof will be collected. Members of the Commission were showed an architectural rendering of the proposed new building and the connector to Saphire Manor. Canvas sides are being proposed for the connectors. There will be no disturbance to the wetlands.

The original building (Inn) consists of a basement with two finished floors. The proposed reconstruction will consist of a basement and one finished floor.

A porch is being considered. This will extend out approximately 8 feet from the building, possibly using a cantilever design for the roof. The proposed porch is located on the street side, and is away from the wetlands.

The current leaching area dates back to about 2008 and sized for the Inn. The current system will be more than adequate for the new use.

At this time, the owner is not sure if they will retain the fountain.

Prior to construction, waddles should be placed around all access areas and this should be noted on revised plan. Revised plan should be submitted to the Conservation Office.

There will be no stockpiling on the property. All debris should be removed from the site.

The timeframe for this project is scheduled to begin this November with the demolition of the Inn. Construction is scheduled to begin in the Spring.
