Dear Current and Future Registered Voters,

The Town Meeting and Town Election are fast approaching. After reading this letter, I suggest you check out the additional detailed information (such as parking) provided on the Town Clerk's page at <https://www.townofsharon.net/town-clerk>, or by scanning the above QR code.

The last day to register to vote for both the Town Meeting and the Town Election is Friday, April 26, 2024. The Town Clerk's Office will be open until 5:00pm for in-person registration. Registration can also be done online until 11:59:59pm at <https://www.sec.state.ma.us/ovr/>.

The Annual Town Meeting will start on May 6, 2024 in the Sharon High School Auditorium at 181 Pond Street. The meeting will begin at 7:00pm (doors open at 6:30pm). The Auditorium Floor Level will be seated first, followed by the Balcony and the Cafeteria, if needed. Only registered voters can vote at Town Meeting, and they must be physically present at the meeting. For those not coming to vote at Town Meeting, the meeting can be viewed on Channel 22 or at <https://sharontv.com/>. Your town meeting Warrant will soon be arriving in the mail, and you can access a digital copy on the Town Clerk's page.

The Annual Town Election will be held on May 21, 2024 in the Sharon High School Gymnasium at 181 Pond Street, from 7:00am – to 8:00pm.
