- Massachusetts has a decentralized system of health administration
 - Each city and town are independently organized for the delivery of local public health
 - Some communities have established public health districts to efficiently deliver services
 - Sharon is a part of the Bristol Norfolk
 Public Health Partners
- Local health departments are responsible for ensuring access to a comprehensive set of health services defined by state law and regulations


BOARD OF HEALTH



- Appointed by Select Board to a term of 3 years on a rotating basis
- Meet once per month
- Given local authority to set policies and make regulations to protect the public and environmental health
- Responsible for health and environmental prevention and control, healthy communities, and disease prevention

HEALTH BUDGET



 Health Department budgets made up only 0.6% of the municipal budget in FY2023 (excluding school department)

3 Largest non-salary expenses:

- Trash subsidy for the disabled and the elderly within a certain income level
- Municipal Dumpster program for the collection of trash and recycling from schools, playgrounds and certain other municipal sites

ENVIRONMENTAL HEALTH

- Ensure clean water and air
- Investigate, plan and respond to and educate the community and key partners about water, food and insect borne diseases



FOOD SAFETY



Ensure food is safe to eat at home, community events, restaurants and in schools



Work to prevent, identify and respond to outbreaks of food-borne illness



Inspect restaurants, grocery stores, schools and residential kitchens (minimum twice per year)

PUBLIC HEALTH NURSING



- In-office nursing for medical questions, consultation, medication teaching, blood pressure checks, heart rate and oxygen saturation checks, weight and random glucose monitoring, lice exams, B12 injections, immunizations/vaccinations, and general guidance navigating the health care system
- Walk-in office hours Tuesday and Friday 9:30 – 11:00 am and by appointment
- Has seen more than 500 individuals in 2022

DISEASE SURVEILLANCE, EPIDEMIOLOGY AND DATA COLLECTION

- Monitor and understand health issues facing the community
- Protect people from health problems and health hazards



VACCINE MANAGEMENT AND INVENTORY DISTRIBUTION FOR CHILDHOOD AND ADULT IMMUNIZATIONS

Yearly influenza clinics

COVID clinics as necessary

Providing childhood immunizations to underinsured and immigrant families

DEVELOP PUBLIC HEALTH POLICIES AND REGULATIONS

Tobacco, Animal, Waste, etc.

Case Study: Hauler of Solid Waste Permit

- Recently instituted a permit for solid waste haulers
- An effort to enforce Massachusetts waste bans and create positive waste habits




TOBACCO CONTROL

Institute policies to raise minimum age of tobacco sales to minors, implement smoke-free housing

CHRONIC DISEASE

- Provide blood pressure clinics to town residents:
 - At Health Department
 - COA
 - Senior Housing

 Work with partners to create conditions and policies which help people make healthy choices



PROMOTING HEALTH

- Various community programs
- Council of Aging
- Housing Authority
- Schools



EMERGENCY PREPAREDNESS AND RESPONSE TO PUBLIC HEALTH EMERGENCIES

- Develop Emergency Preparedness plans
- Respond quickly and ability to deploy resources during public health emergencies
 - COVID ability to set up clinics quickly to administer vaccines

INJURY AND VIOLENCE PREVENTION

- To develop interventions and implement policies to help with prevention of drug misuse and overdose
- Key partner for the State and responsible for ensuring the health of the community and serve on the front lines of the opioid epidemic
 - Received money for opioid abatement setting up a variety of programs and services to assist with impact of Opioid use
 - Facilitate the State's distribution of Narcan and provide training on its administration

VOLUNTEER OPPORTUNITIES

- Sharon Medical Reserve Corp (MRC):
 - Town volunteer program for residents in both the medical and nonmedical field to assist in improving the health and safety of the town
 - Volunteers have helped with flu and COVID vaccination clinics in the past and are committed to assisting in a public health emergency
 - There are currently around 40 volunteers in the MRC
