MINUTES SHARON BOARD OF SELECTMEN March 14, 2018

The meeting of the Sharon Board of Selectmen was called to order at 1:00pm in the Town Hearing Room at the Sharon Community Center with Chairman John J. McGrath, Selectman William A. Heitin, Selectman Walter B. Roach, Town Administrator Frederic E. Turkington, Jr. and Assistant to the Town Administrator Lauren Barnes. The meeting commenced with the recitation of the Pledge of Allegiance.

Conditional Offer of Employment - Christopher Dumais

Chief Kaufman appeared before the Board and explained an immediate opening has occurred due to the transfer of Officer Ryan McGrath to the Foxborough Police Department. Mr. Dumais has been fully vetted and he was recently approved by the Board of Selectmen to be a Sharon Special Police Officer. As previously discussed, we agreed to create a candidates list for future hires from the last (and final) Civil Service list pending the implementation of a new non Civil Service written exam. Mr. Dumais is the only name left on this list from our previous discussions. We are currently planning for a written entry level exam for police officer later this year. Chief Kaufman then provided the Board with Mr. Dumais' credentials.

Special Police Officer Appointments - Simon & MacDonald

Chief Kaufman appeared before the Board and provided the Board with Mr. Simon's and Mr. MacDonald's credentials. A thorough background investigation has been completed on both candidates, and the Chief is confident both will be excellent additions to the Special Police Division.

One-Day Liquor License - Ward's Berry Farm for Private, Family Event

Bob Ward of Ward's Berry Farm appeared before the Board. He explained to the Board that he is seeking oneday liquor licenses for two private family events for his nieces, one on August 3 and the other on September 29. He knows the issues may be of sound and traffic and will work to mitigate both. He is also interested in talking more about the general option of hosting private events where alcohol is served. The Board noted that every private event would require a license, and the concept is good, but Mr. Turkington explained that staff would need to review plans each time to ensure parking and noise will not be a problem for neighbors.

Civil Defense Relocation Discussion

Civil Defense Director Michael Polimer, Michael Corman and Chuck Levine appeared before the Board.

Chairman McGrath asked Mr. Polimer if Civil Defense were to be able to pick their site, what would be their order of preference. They would like to be in the PSB/DPW yard as their first option, then somewhere in the Deborah Sampson property. Chairman McGrath noted that the PSB/DPW property is not an option. With respect to the Deborah Sampson property, there are three options – in the "triangle" area (across the street to the right of the ballfields), and then on Parcel F, parallel to Cedar Street (this would require further exploration and would likely require a land swap), near the dog park. Mr. Polimer believes the location in the back corner on Parcel F is a good location, and screening (trees, bushes, etc.) could be added so the building isn't as visible. This location is their first preference. He went on to say that the "triangle" area is also a fine site, but would require a land swap. Recreation Director Linda Berger noted that the location area proposed near the tree line on Parcel F would be okay with the Recreation Department and the Recreation Advisory Committee.

Selectman Roach asked if Civil Defense will have enough money to construct the building if an underground tank is discovered on the site. Mr. Turkington noted that there are only several weeks to modify the figure for the Town Meeting Warrant, and if a tank is not discovered, then the additional funds will be returned. Selectman Heitin believes the "triangle area" is the best place, but is fine with the back corner on Parcel F. Selectman Roach said he spoke with Town Engineer Peter O'Cain about the "triangle" area, and the steep grade to South Main Street would make it difficult. Chairman McGrath summarized that the Parcel F site is Civil Defense's first choice and the "triangle" area as their second choice. Mr. Coman added that if the town cannot purchase the house at the corner of East Foxboro Street, an easement could be obtained.

<u>MOTION</u>: To look first at the parcel in the corner [on Parcel F], as discussed, and the "triangle" area as a fallback

Selectman Heitin explained that the Moderator has agreed to place the zoning articles on the second night of Town Meeting, May 8. The Moderator wants to help streamline Town Meeting, and plans to introduce a Consent Agenda, consisting of eight articles, that are the perfunctory articles Town Meeting votes each year, that can be voted in one motion.

Zianette Frost of North Main Street, and a member of SharonCARES, would like child care provided at Town Meeting. She spoke with high school principal Dr. Libano, and he explained the town providing child care is a liability issue. A long discussion followed, and Selectman Heitin suggested that Ms. Frost speak with the School Department and the School Committee. If she is not successful, perhaps SharonCARES can purchase a one-day liability insurance policy.

Mr. Turkington explained that should the Finance Committee not vote to place money in the stabilization fund, Article 12 would be pulled. He also pointed out that there may be no need to extend the temporary moratoria, once the Cannabis Control Commission issues its regulations in the next week.

Mr. Turkington noted that the SharonCARES group still supports a full ban on recreational marijuana. The process is: Town Meeting would need to vote, by a 2/3 majority, to ban recreational marijuana, and the same language would need to be approved at the Town Election two weeks later. The ballot question is binding only if the zoning article passes Town Meeting. He summarized the warrant articles related to recreational marijuana.

Ms. Frost would like the Board of Selectmen to write a letter to the Cannabis Control Commission, asking them to delay approving Four Daughters Compassionate Care's (FDCC) conversion pending the ballot question. Mr. Turkington explained that this request came in via email at 10:59am this morning. Mr. Turkington told the Board that SharonCARES asked a Commissioner of the Cannabis Control Commission (CCC) and the Attorney General's Office if a conversion in this case would be trumped by a ban, and they have not received a ruling. He does not believe the CCC will issue a ruling because they are responsible for the licensing process. What will likely happen is, FDCC will come before the Board, looking for a host community agreement, for the larger site on Route One for cultivation and sales; they cannot file for a license without one. Ms. Frost wants the Town to have a say as to whether or not Sharon should have a recreational marijuana facility. Chairman McGrath agrees that the Town should have a right to vote. Selectman Heitin would like to wait for guidance from counsel, as there are some important issues. Selectman Heitin noted that a conversion is possible, according to Town Counsel. Mr. Turkington is awaiting Town Counsel's review of the feedback from SharonCARES on the zoning bylaw amendment banning recreational marijuana.

MOTION: To approve the order of the Annual Town Meeting Warrant, as discussed (Heitin – Roach) 3-0 **PASSES**

Annual Town Election Ballot Question Vote - Ban on Recreational Marijuana

Mr. Turkington recommends delaying a vote until the next meeting. The only question is whether or not we'll be adding in language, suggested by SharonCARES this morning, about whether or not to add into the ban any applicable conversions. The Board agreed.

- Regarding solid waste implementation, he is meeting with Cascade today to place the final order for the trash carts. He has ordered a handful of the larger carts in case not everyone that did not register did not want the 35-gallon cart.
 - A contract with Waste Zero has been signed to provide the overflow bags.
- Finance Committee is meeting on Thursday evening to make up for the Monday meeting they cancelled in advance of the storm.
- Planning Board is holding its public hearing Thursday on the zoning articles related to recreational marijuana.
