MINUTES SHARON BOARD OF SELECTMEN

July 10, 2018

The meeting of the Sharon Board of Selectmen was called to order at 7:00pm in the Town Hearing Room at the Sharon Community Center with Chairman William A. Heitin, Clerk Walter B. Roach, Jr., Selectwoman Emily E. Smith-Lee, Town Administrator Frederic E. Turkington, Jr. and Assistant to the Town Administrator Lauren Barnes. The meeting commenced with the recitation of the Pledge of Allegiance.

Veterans Monument Proposal Discussion

Resident JJ McGrath appeared before the Board. He explained that he had an idea to erect a fountain to honor veterans of the Korean War, Vietnam War, Gulf War, Iraq and Afghanistan wars. The fountain would be representative of the fountain that was formerly in Post Office Square. He wrote to the Simoni Foundation for financial assistance, and they donated \$8,000 toward the project. He found a sister fountain in the center of Wrentham, and through his research, he found that in order to replicate the fountain from Post Office Square, it would cost \$65,000+. He understands that it may not be financially feasible to replicate the fountain, but rather design a different one. Mr. McGrath suggested the fountain could be placed in Post Office Square or on the grounds of the new Town Hall property. He believes a committee should be formed to develop a design, recommend a location and fundraise.

Chairman Heitin noted that there are talented architects and artists here in Town that may be willing to get involved. Mr. McGrath believes this could be a community project, which is a good thing. Selectwoman Smith-Lee finds the idea appealing, but doubts there is sufficient space in Post Office Square. She agrees that this could be a community effort. Mr. Turkington added that if the plan differs from the original proposal that was suggested to the Simoni Foundation, the Town would have to give the Foundation the opportunity to ask for their money back or allow the Town to use it for the new design. Mr. McGrath agrees that the Standing Building Committee should be consulted as to whether or not it is an option at the new Town Hall site. Chairman Heitin suggested that the Board take this information and digest it, and add this topic to the next meeting agenda to continue the conversation.

The Board thanked Mr. McGrath for his time.

Appoint Donald Brewer as Deputy Chief of Police & Approval of Employment Agreement

Mr. Turkington explained that this is the standard employment agreement for the Deputy Chief of Police. Chief Ford looks forward to working with Deputy Chief Brewer, and noted his meteoric rise since joining the Department in 2006. Chairman Heitin would like to do a pinning ceremony in the near future for the Deputy and the new Lieutenants, and Chief Ford offered to hold it at the Public Safety Building.

Sacred Heart Site Vote - Parcel T No Longer Needed for Outdoor Recreational Purposes

MOTION: That the following parcel of land is found to be no longer needed for outdoor recreational purposes:

That the portion of the Parcel B on land known as the Sacred Heart Site, which was acquired by the Town by deed of the Order of the Brothers of the Sacred Heart of New England, Inc. dated December 26, 1974 and recorded in the Norfolk Registry of Deeds in Book 5099, Page 169 and shown on a plan entitled "Plot Plan of Sacred Heart Property, Sharon, Mass." dated June 1973 by the Sharon Engineering Department which plan is recorded in said Registry as Plan Number 1102 of 1974, Plan Book 247, which is currently unused and is held under the care, control and management of the Board of Selectmen for outdoor recreation purposes, be transferred to the care, control and management of the Board of Selectmen to use for general municipal purposes and/or construction of municipal building(s) and related facilities and/or parking.

The property no longer needed is shown as Parcel T on a plan dated June 15, 2018, prepared by Sharon Survey Service, 10 East Chestnut Street, Sharon, MA 02067, containing approximately .82 acres. A copy of this plan is attached to this vote and is on file with the Office of the Town Clerk.

In exchange for the removal of said Parcel T from the open space and parkland restriction under Article 97 of the Massachusetts Constitution, the Board of Selectmen will transfer certain land from the care, custody, management and control of the board of selectmen to the board of selectmen, for outdoor active and passive recreation and open space. The exchanged parcel is approximately 2.2 acres of land and is identified as Parcel F on the "Plot Plan of Sacred Heart Property, Sharon, Mass." dated June 1973 by the Sharon Engineering Department which plan is recorded in said Registry as Plan Number 1102 of 1974, Plan Book 247, and is described in a deed to the Town of Sharon recorded at the Norfolk Registry of Deeds in Book 5099, Page168. (Heitin – Roach)

The Town Administrator reported the following:

- Department heads met with the Master Plan consultants today. A community-wide survey will be distributed next month.
- Two firms have expressed interest in erecting billboards along Route One. The Town has asked both firms for mitigation funds.
- The Town's insurance package is complete, and is approximately \$30,000 under budget, even with the additional coverages for cyber and umbrella.
- With respect to the trash program, there are about 300 households that did not receive barrels, but those issues are being addressed. There were approximately 100 customers who were not being charged by Republic Services, but since the Town is taking over billing, that will be remedied.
