SEPTEMBER 9, 2014

Pursuant to the provisions of the Warrant of August 1, 2014, the inhabitants of the Town of Sharon qualified to vote in elections, met in the Sharon High School Gymnasium at 7:00 A.M., Tuesday, September 9, 2014. The meeting was called to order by Town Clerk Marlene B. Chused who read the call and return of the warrant. The warden of the election was Lynne M. Callanan.
